

## God's Five Stones Funding Proposal

**Funding Proposal**

As documented on [GodsFiveStones.com](https://GodsFiveStones.com), Andrew Paquette, Ph.D., has uncovered cryptographic algorithmic codes embedded in every State Board of Election (SBOE) voter registration database we have examined. The algorithms permit criminal agents to create falsified voter records assigned legitimate SBOE voter ID numbers.

- The Florida November 12, 2024, database contains 16,401,509 records, of which 2,283,149 (14%) share first and last names with at least one other record.
- Of these 16 million plus voter records, 935,654 (6%) records showed name + age matches. In-person canvassing has demonstrated that these modified duplicate records are created to get legitimate SBOE voter IDs for modified duplicate "voters" who do not exist.

**The goal of the God's Five Stones Foundation [a 501(c)3 organization] is to conduct a media campaign buttressed by court filings to support a presidential executive order demanding all SBOEs abandon their current voter registration files (corrupted by secret codes and large percentages of illegal multiple voter IDs created for non-existent voters) in favor of federally mandated in-person registration of voters legally licensed to vote. The presidential executive order will require paper ballots, which are hand-marked and hand-counted. The national security nature of the presidential executive order will allow federal national security compliance oversight of the Constitutionally mandated delegation to the states, giving the state legislatures the responsibility for setting rules and procedures for state-conducted presidential elections.**

The Help America Vote Act (HAVA 2002) makes it illegal for a voter to have more than one SBOE voter ID. We must not allow any party to use illegal SBOE voter registration rolls to steal majorities in the U.S. House and Senate in the 2026 mid-term elections. Democratic control of the U.S. Congress in 2026 would threaten to ruin President Trump's last two years in office with a repeat of the 2020 resistance and impeachment drama.

The modified duplicate files are then hidden in the SBOE voter registration database, available for the criminals to activate the falsified voter IDs to request mail-in ballots that are certifiable because the voter ID requesting a mail-in ballot matches the voter ID on the outside envelope of the mail-in-ballot. The election fraud requires criminal access to the SBOE voter registration computer server. Since no mail-in votes are mailed to fictitious voters, the election fraud is committed entirely within the SBOE server. Mail-in ballots are recorded as requested in the SBOE database, printed, and run through the SBOE tabulation machines as legitimate.

President Trump is now aware that criminal agents have hacked into SBOE computers to implant algorithms, i.e., cryptographic codes within the SBOE computers that allow the creation of millions of modified duplicate records that riddle our SBOE voter registration databases

throughout the nation. These cyberattacks on the nation's voter registration database represent a national security emergency in that foreign enemy cyberagents could avail themselves of these "backdoors" into the SBOE voter registration computers.

Guided by President Trump's attorney, Peter Ticktin, we have focused on contesting the 2024 U.S. House of Representatives election in Pinellas County (Tampa and St. Petersburg), Florida's District 14. incumbent Democrat Kathy Castor stole the election from Republican Rocky Rockford after 196,986 mail-in ballots were requested on September 9, 2024, approximately 2 months before the 2024 general election. Florida law requires a voter to fill out a Florida Vote-By-Mail request form that demands a voter's driver's license number or the last four digits of the Social Security number. When these fields are left blank, the request is informally called a "No-No" ballot. Across Florida, Ticktin has uncovered 592,335 "No-No" ballots listed to requesters who did not provide the required identification but were mailed a ballot anyway. Of these illegally issued ballots, 475,340 (80%) were returned to their counties, where they were processed unlawfully and counted as votes.

Under Peter Ticktin's direction, Dr. Corsi will conduct a media campaign consisting of radio and podcast interviews, supplemented by his authoring articles that cover elections in states across the nation where GOP campaigns are threatened by Democratic Party-controlled SBOE voter rules, regulations, and procedures designed to facilitate election fraud—specifically the registration of falsified voter records enabled by the algorithms to create and vote falsified found in the SBOE records as modified duplicate voters.

Peter Ticktin has filed three legal challenges: (1) in a Florida court challenging the Rockford-Castor election outcome; (2) in a Tallahassee court challenging that the Florida SBOE voter registration database is corrupt beyond repair; and (3) with the U.S. House Administrative Committee demanding an investigation of the FL-14 race under the auspices of the Federal Contested Elections Act.

Our goal will be to have President Trump act during 2025 so the necessary executive orders and other legal structures can be put in place requiring the states to secure voter integrity before the 2026 midterm elections.

In addition to supporting Peter Ticktin and Dr. Corsi's efforts as described here, funding will permit Dr. Paquette to extend the number of SBOE voter registration databases he can analyze for the presence of algorithms and the identification of modified duplicate voter records. With sufficient funding, Paquette can obtain SBOE sub-files (e.g., voter history lists), enabling him to conduct detailed analysis to demonstrate the use of modified duplicate "voters" in stolen races. With sufficient funding, we can conduct more extensive in-person field canvassing that will allow us to statistically estimate the proportion of duplicate names that are falsified voter records created by duplicating and modifying a source (possibly once legitimate) initial voter record.

We are not counting on winning court challenges to win the voter integrity war. By publicizing the court filings and challenging various elections in several different states, we believe there will be sufficient national demand to justify and support President Trump's issuance of the contemplated executive order. Your financial support is essential to allow us to do the work necessary to achieve

our goals in the time remaining before the 2026 election. We cannot afford to lose this election integrity battle if we are serious about maintaining our freedom.
